The purpose is to use stocks as the main investment target asset and operate the rate of change in net asset value per seat in conjunction with the rate of change in the underlying index using the "Nasdaq-100 Index(Total Return)" as the basic index.

Underlying Index

Total Return Index, which is a stock listed on the NASDAQ Exchange in the U.S., selects the top 100 companies based on market capitalization, and reflects the total return added to the dividend yield assuming that pre-tax cash dividends of the constituent items are reinvested

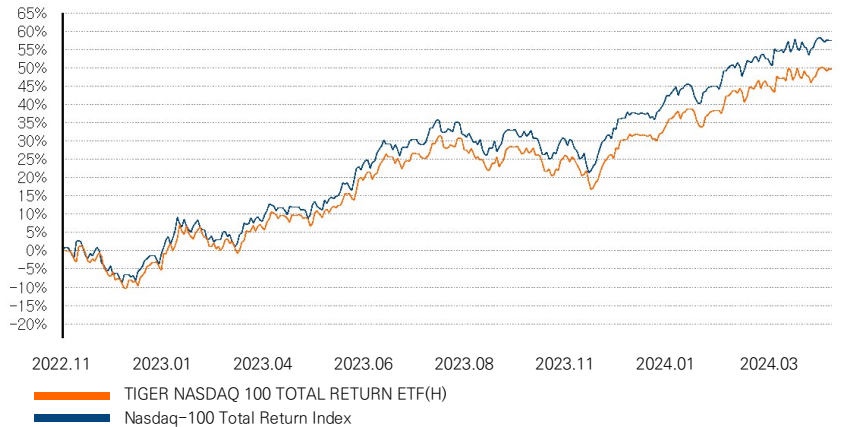
