NASDAQ100 Daily Covered Call Target Premium 15% Index consists of the top 100 companies listed on the Nasdaq Global Market and sells next-day expiring NASDAQ100 ATM options each business day with an annualized premium target of 15%.

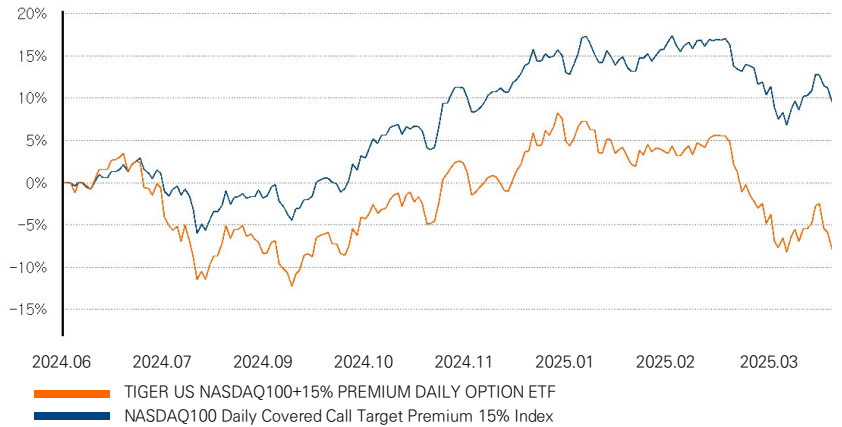
